Section 4 (1) (b) of the Right to Information (RTI) Act of 2005 pertains to the legal declaration made by Dr. Arundhati Moulik (Roy), who serves as the Teacher In Charge at Tarakeswar Degree College. Our college is affiliated with the University of Burdwan, Bardhhaman, and is supported by the Government of West Bengal. The college has successfully established an RTI Cell in compliance with the West Bengal Government Memo No. ED-1964/2017 dated 22.09.2017. The Governing Body has officially approved this initiative during their meeting on 25.08.2020. Dr. Arundhati Moulik (Ray), the Teacher In-Charge of Tarakeswar Degree College, has been appointed as the appellate authority following the retirement of the College principal. This resolution was formally approved during the Governing Body session convened on 05.04.2024.

The college operates under the guidance of its Governing Body, IQAC, and College Development Committee. It strictly adheres to the rules and regulations set by the University of Calcutta and the Government of West Bengal. As a "Grant-in-Aid" institution, the college's financial transactions are audited by auditors recommended by the Director of Public Instructions, Education Directorate, Government of West Bengal. Various bodies within the college ensure discipline is maintained on campus, and all cells or committees fall under Statutory Bodies. To request information under the RTI Act, individuals can submit an application along with a non-judicial postal stamp worth Rs. 10.00 in favor of the Teacher In-Charge at Tarakeswar Degree College. This application can be sent to the State Public Information Officer (SPIO) at Tarakeswar Degree College or submitted in person at her office. All information about the college is accessible to the public and can be obtained by Indian citizens.
